Leaders Report submitted by Councillor E Hamilton

I attended the first session at The Wilmot Street Centre of the Sing along with Ellie. A group funded by the Town Council, for people who are suffering from dementia and their carers. It also welcomes residents who just want to sing their hearts out. It's important to state that you don't have to be a good singer, enthusiasm is the main factor. It was a fun afternoon and I encourage everyone to go along.

Because of this prior engagement I was unable to attend the Charles Hill tour and I hope that those of you who did attend were impressed with both the outside of the building and the high spec finish inside as I was when I went round a few weeks ago.

Members continue to attend the coffee mornings concerning Charles Hill and also Heanor Vision meetings.

Work has started on developing the new website and rebranding the Town Council

The Council have responded to the consultation on the Local Plan and I strongly urge individual members of the council and residents to use this opportunity to respond with any concerns they may have as this is a very important document as it sets out the vision and framework for future development in Amber Valley up to 2040.

The consultation period finishes on 3rd April 2024 at 4.30pm.

I am very pleased to congratulate Heanor Town Football Club who beat Long Eaton 2-0 to reach the final of the Derbyshire Senior Cup Final which will be played on 17th April 2024 at Pride Park Derby. There opponents will be Buxton.

This is the first time for 45 years that they have done this, and it is something that should be celebrated.

Busloads of supporters will be going to this, and I would like to suggest that we as a council pay for 3 buses for this purpose

I would therefore like to propose that -

The clerk can look into this cost which will be approximately £1750 and report back to council at the next meeting. This was **Resolved** accordingly.

122 Mayors Announcements

The Mayoress and I presented a cheque for £2000 to Infinite Wellbeing to allow them to develop services for our community.

I attended the semi-final of the Derbyshire Senior Cup when Heanor Town deservedly beat Long Eaton to progress to the Final for the first time in 45 years .The Final will be played on April 17th at Pride Park Stadium.

I have been asked to sit as the independent member on the Florence Shipley and Ambervale Amenities Committee and I attended my first meeting last month.

As Mayor I have signed the funding agreement with Amber Valley Borough Council, on behalf of the Town Council, for our £100,000 contribution to Charles Hill Community Sports Hub. This will be paid over before the end of this month.

The council considered a request that the grant of £1650.00 previously allocated for a Cinema in the Park event that did not take place, be allowed to be used for further community cinema events at Infinite Wellbeing.

(e) DALC Subscription

Resolved: To approve the enhanced subscription at a cost of £2,031.60 for 2024/25.

(f) Groundwork Nottingham – Tree Work Red River LNR

Resolved: To approve the costs of the necessary tree works at a total of £2490.00 (inclusive of VAT).

(g) St Lawrences Church – Outdoor Lighting of Church

Resolved: To approve the Town Council, meet the costs of the outdoor lighting from dusk until midnight to a total of up to £1846.80.

(h) Electoral Commission Boundary Review

Resolved: To submit the following response from the Town Council -

The Town Council welcomes the proposed recommendations by the Electoral Commission for the Derbyshire County Council Divisions for 2005 as they keep the single member wards, which we feel are more effective in reparenting communities. The recommendations reflect the County Council Divisions covering the Town Council prior to the 2005 changes.

The proposals for Greater Heanor seat to include Aldercar, Codnor, Langley Mill and Loscoe better reflects the community links between these areas along with the good transport links and links with adjacent Town and Parish Council's. It would also almost reflect the old Loscoe Division of Derbyshire County Council which existed prior to 2005 which combined Aldercar, Langley Mill and Loscoe and certainly the historic links when they were all part of the old Heanor Urban District Council

The previous boundary of the Greater Heanor Division post 2005 did not reflect any community or easy transport links

The proposal for Heanor Central covers the existing Borough Councils Ward of Heanor East and Heanor West (prior to the boundary review for the 2024 Elections) This is a better reflection of these communities as they are seen as one whole community within the Town and have excellent transport links. Again, they reflect the boundaries of the old Heanor Urban District Council.
