105 Charles Hill Playing Fields

This Council recognises the need for Loscoe to have a community facility based at Charles Hill Playing Fields. For that reason, it has been negotiating with Amber Valley Borough Council to try to achieve this outcome. As part of those negotiations, and in order to make possible such a facility, the Town Council need to make a financial contribution. As previously agreed, the Town Council would procure a Public Works Loan Board loan to fund the Town Council's contribution. Members need to be aware that the funding of the Public Works Loan Board loan will necessitate an increase in Council Tax from the Town Council, and this will be worked into the budget proposals presented to the January 2020 Full Council meeting. It would also be necessary to utilize £30,000 (previously earmarked for a community room at Loscoe from balances) to contribute to preparation costs for the project. The Town Council will have representation on the Community Interest Company, which, moving forward, will manage the new facility.
