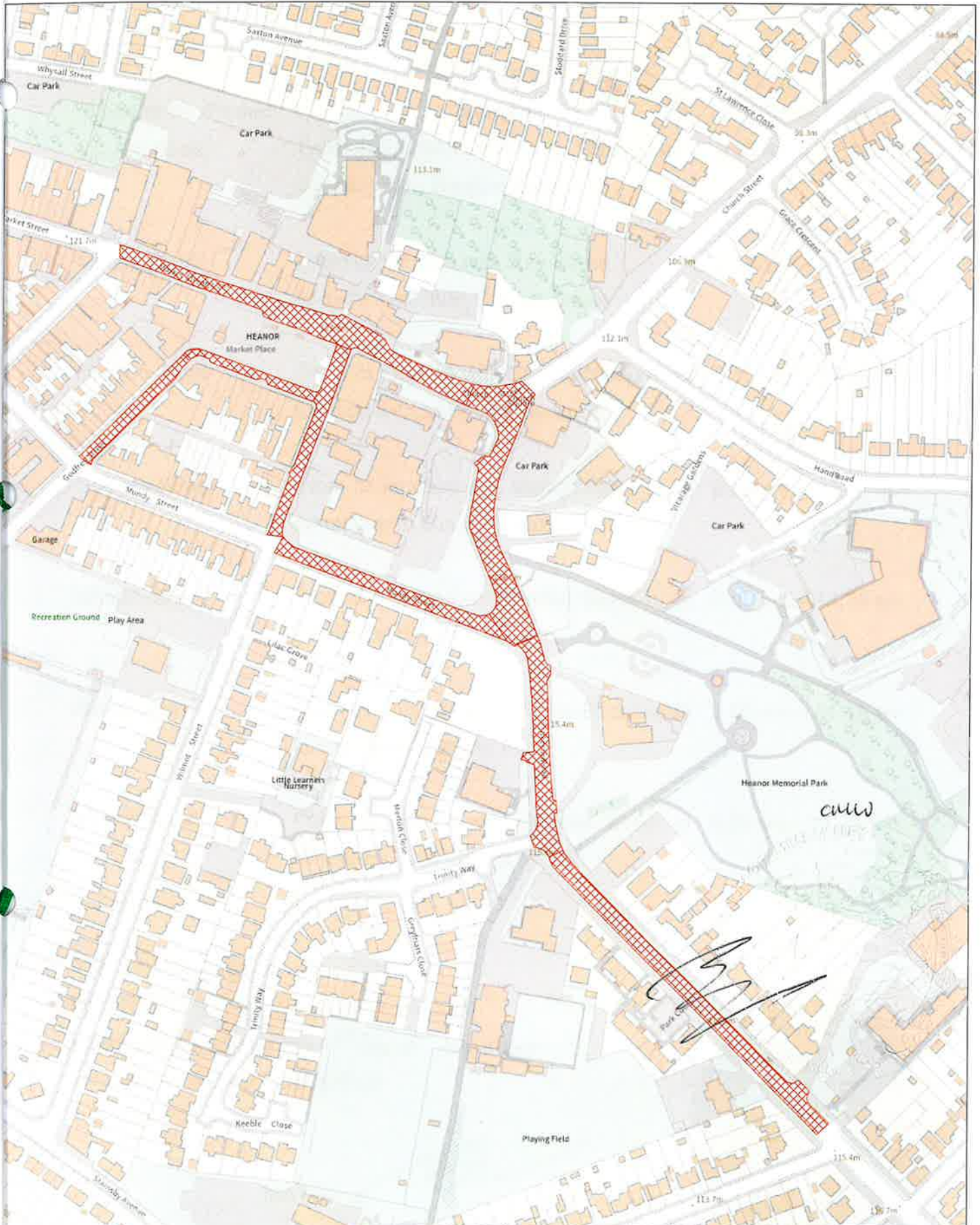

WHEREAS AMBER VALLEY BOROUGH COUNCIL (hereinafter referred to as "the Council") are satisfied that vehicular traffic in parts of the Borough of Amber Valley should be restricted by reason of a Remembrance Parade in the Town Centre of Heanor on Sunday 10 November 2024.

NOW THEREFORE the Council in exercise of its powers under Section 21 of the Town Police Clauses Act 1847 as amended by Schedule 3 to the Criminal Justice Act 1967 and of all other powers it enabling in that behalf hereby makes the following Order:-

1. No person shall cause or permit any vehicle other than a vehicle connected with the emergency services a statutory undertaker or for which a permit has been issued by the Council to proceed along the lengths of road at the times specified in the Schedule to this Order
2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies to an Act of Parliament
3. The Order will come into operation on the 10 day of November Two Thousand and Twenty-Four and may be cited as the Amber Valley Borough Council (Heanor Town Centre) (Temporary Closure) No. 4 Order 2024.
